Reshaping Somalia's Education for Development

Education is a cornerstone of statebuilding/peacebuilding and a key indicator of human development. Countries around the world spend a significant amount of their national budgets on education as an investment for their country's future. The state of Somalia's education is a complex one. For instance, despite the right to education being enshrined in Somalia's Provisional Constitution, over 70% of school-aged Somali pupils do not have access to basic education. Yet, thanks to the efforts of successive Somalia governments, international partners, and the dedication of local communities, the country's education systems have witnessed slow but noticeable improvements. Recent years saw the development of important educational policies, increased overall school enrolment rates, re-established national exams, a new curriculum framework and limited professional development for teachers. Despite these positive steps, the country is facing considerable educational challenges that require the attention of policymakers, educationalists, researchers, and international partners.

Building on our Human Capital Development Series, The Heritage Institute and City university of Mogadishu have launched this Special Call for Policy Papers on Education. The Heritage Institute for Policy Studies and the City University of Mogadishu have developed a baseline study that has informed the National Development Plan (NDP-9). The objective of this study was to create "an inclusive, indigenous and sustainable Human Capital Development Mechanism (HCDM)." The HCDM research consortium produced a comprehensive report on education, health and the productive sector (agriculture, fisheries and livestock), in order "to develop human capital development strategy and to propose a mechanism that facilitates synchronization of the efforts by the human capital development stakeholders."

This Call therefore aims to capture the progress and identify current gaps and future challenges with the hope that researchers, through evidence-based policy research, will bring insights and solutions to the educational challenges the country is facing.
